## Hersiening van die Grondwet

Gedurende die 2021 AJV is daar besluit om die Grondwet te hersien. Die nuutverkose komitee het 'n sub-komitee aangestel om die hersiening en vernuwing van die grondwet te bestuur. Die vernuwing het die volgende ten doen:

1. Om die bewoording en mening van die klousules duideliker en meer omskrywend te maak.
2. Die gedelegeerde magte en regte van die komitee duideliker en meer omvattend te omskryf;
3. Groter duidelikheid rondom die doelstellings en verwagtinge van Blue Ridge, ons beeld en inskakeling in die groter prentjie van Danabaai, met sy natuurlike diversiteit en unieke natuurlewe; en
4. Om ook in lyn te wees met hedendaagse tendense, realiteite, verwagtinge en om aan alle wetgewing en munisipale ordinansies te voldoen.

Die sub-komitee bestaan uit twee komiteelede, naamlike Pieter Myburgh en Reiniet van Huyssteen, asook Arrie van Huyssteen as 'n gekoöpteerde lid. Die komitee is ook van plan om nog lede te koöpteer, verkieslik met regsagtergrond, om die komitee by die staan met raad en wysheid.


Die oorspronklike idee om die Grondwet deur 'n regs kundige persoon te laat hersien, is finansieël net nie bekostigbaar nie.

Die sub-komitee sal binnekort uitreik na al die eienaars met 'n voorlegging hoe die proses sal verloop vir eienaars se insae en nodige kommentaar. Om die proses spoedig en suksesvol te kan afhandel, is dit belangrik dat eienaars aktief moet deelneem aan die konsep formulering en finale goedkeuring van die veranderinge in die grondwet om die proses so inklusief moontlik te maak.

## Changes to the Constitution

As tasked by the 2021 AGM, the Committee has put together a sub-committee to drive the project to relook and refresh the Blue Ridge Constitution to achieve four main objectives:

1. to clarify the wording of clauses that are open for different interpretations;
2. to give much clearer directions as to the delegated powers of the Committee;
3. to clarify clearly what the HOA wants the look and feel and 'brand' of Blue Ridge to be; and
4. to be more in sync with current reality – the new normal.

The sub-committee consists of two committee members being Pieter Myburgh and Reiniet van Huyssteen as well as Arrie van Huyssteen as a co-opted member. The sub-committee will try to get at least one more member with hopefully a legal background co-opted, onto the team. One of the initial ideas was to appoint a legal expert to drive the entire process, but that will cost a lot of money and no one is prepared to give us a fixed cost which will mean the project will run with an 'open cheque book' at around R1400 per hour.

We will reach out to all members shortly with a proposed process to be followed for comment and input. For this project to be concluded quickly and successfully, it will be very important for all members to participate actively in both the drafting phases and the final approval phase to make the Constitution as inclusive as possible.
