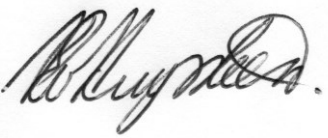

A penalty of R500 per week will be levied until the breach has been rectified and the Managing Agent has been informed in writing that it has been rectified. Agents must rotate their signs amongst themselves in line with Municipal bylaws. The HOA cannot take responsibility if signs are removed or damaged.
