The Constitution of Blue Ridge HOA allows for the keeping of certain Pets, including dogs (refer Clauses 5.8 and 9.2.7) and requires the HOA Committee to draw up more detailed rules as part of the Conduct Rules to manage the keeping of dogs. This has been done by the Committee to ensure that the movement and excessive barking of dogs that can cause a nuisance are managed adequately. It is also important to note that should the back yard need to be fenced in to allow the dog(s) to move around in the back yard, that the boundary walls must be erected strictly in accordance with the Architectural Rules (Clause 2.10).	Die Grondwet van Blue Ridge HEV laat die aanhou van sekere Troeteldiere, insluitend honde toe (verwys Klousules 5.8 en 9.2.7) en vereis van die HEV Komitee om gedetailleerde reëls as deel van die Gedragsreëls op te stel vir die aanhou van honde. Dit is gedoen deur die Komitee om te verseker dat die beweging en uitermate baie geblaf van honde wat 'n steurnis kan veroorsaak behoorlik beheer kan word. Dit is ook belangrik om kennis te neem dat indien die agterplaas omhein moet word sodat die hond(e) daar kan rondbeweeg, dit streng volgens die Argitektoniese Reëls opgerig moet word (Klousule 2.10).
As indicated in the Conduct Rules under Section 4, owners are again reminded that only two SMALL dogs under 10 Kg in weight each are allowed, that dogs must be kept inside the Erf of the owner and are not allowed to roam around in Blue Ridge without being on a leash. If any complaints are received the Committee can make use of any or all of the following options to address the complaint: a written warning, a R500 penalty or the permission to keep your dog(s) is withdrawn. A list of SMALL DOG breeds in South Africa is available at your veterinarian. Pet owners must ensure that their Pets get the required injections/inoculations from a veterinarian on an annual basis. Please attach a copy of the clinic card.	Soos aangedui in die Gedragsreëls onder Afdeling 4, word eienaars weereens herinner dat slegs twee KLEIN honde onder 10 Kg in gewig toegelaat word, dat honde te alle tye binne die Erf van die eienaar gehou moet word en nie in Blue Ridge mag rondbeweeg sonder 'n leiband nie. Indien daar klagtes ontvang word kan die Komitee van enige of al die volgende opsies gebruik om die klagte aan te spreek: 'n skriftelike waarskuwing, 'n boete van R500 of die toestemming vir die aanhou van u hond(e) word terug getrek. 'n Lys van KLEIN HONDE rasse in Suid Afrika kan by u veearts verkry word. Troeteldier eienaars moet verseker dat hul troeteldiere die vereiste inspuitings/inokulasies van 'n veearts op 'n jaarlikse basis kry. Heg ook asb. 'n afskrif van die kliniek kaart aan.
