Die geraas van tuindienste kan ook 'n moontlike oorsaak wees. Daar het ook al situasies plaasgevind waar honde die bokke gejaag het. Meer en meer aansoeke word ontvang vir die aanhou van honde en sommige komiteelede voel dat dit problematies raak en gedrag van honde sal baie streng gemonitor moet word.</p> <p>Die voorstel vir "mesh" word nie goedgekeur nie, aangesien die aantal voorvalle nie die uitgawe regverdig nie. Plante sal slegs in bestaande beddings geplant word indien nodig en moet nie sodig geplant word dat die plante mekaar begin verdring nie.</p>	<p>EP makes a proposal to put up a mesh on the East Fence, where two antelopes got stuck over the years and subsequently died.</p> <p>One tried to jump over the fence after two rams fought and the other must have been startled and tried to run through the fence.</p> <p>It is suspected that the antelope usually get scared by the barking of dogs. The noise from garden services may also be a reason. There have also been situations where dogs have chased the antelope. More and more requests are being received for the keeping of dogs, and some committee members feel that it is becoming problematic, and the behaviour of dogs need to be monitored very strictly.</p> <p>The proposal for mesh is not approved, as the number of incidents do not justify the expense. It is felt that the behaviour of dogs in the Estate should rather be managed more strictly, and garden services should be more aware of the buck when mowing the lawn.</p> <p>Plants and rocks were donated by a few owners. Appreciation will be done in the newsletter.</p> <p>No new plant beds should be made. The committee feels that a nice balance has been struck between plant beds and the open lawn areas. Plants will only be planted in existing beds if necessary and should not be planted so densely to start displacing each other.</p>
