Die munisipale riglyne bepaal 8.5 meter. Blue Ridge se Boureëls beperk die hoogte tot 8 meter en die Boukomitee kan elke geval en aansoek evalueer en waar dit geen invloed op omliggende eiendomme sal hê nie, en met die omliggende eiendomme se goedkeuring, kan die reël verslap word tot op 8.5 meter. | EP has sent an email with proposals for amendments to the Architectural Guidelines. These proposals will be discussed in the January meeting to ensure the changes are ready to be submitted to Members at the AGM. It is crucial to better define ambiguous areas to assist future building committees. A request has been received from an owner to relax the guideline regarding roof height to exceed 8 meters. The municipal guidelines stipulate a maximum height of 8.5 meters. Blue Ridge Building Rules limit the height to 8 meters and the Building Committee can evaluate each case, and where it does not impact surrounding properties, and with the surrounding property's approval, the rule may be relaxed to allow up to 8.5 meters. | |
