Die vergadering is dus behoorlik saamgestel en kan voortgaan.</p> <p>Vergadering gaan slegs 'n paar dringende items aanspreek en sal dus nie die volledige agenda van die maandelikse vergaderings volg nie.</p>	<p>First meeting after the AGM and 5 newly elected (4 re-elected and Brenda Coetzee newly elected) Trustees are present as well as one Trustee starting second year of 2-year term (Piet Boshoff). The meeting is therefore properly constituted and can proceed.</p> <p>The meeting is only going to address a few urgent items and will therefore not follow the full agenda of the monthly meetings.</p>

	<p>'n Voorstel word deur LN gemaak dat verantwoordelikhede waar moontlik in plek bly om kontinuïteit te verseker. Boshoff</p> <p>Ander dringende aspekte soos waterlekke, elektrisiteit onderbrekings, ens. sal deur enige Trustee wat op daardie oomblik beskikbaar is aangespreek word.</p>	<p>A proposal is made by LN that responsibilities remain in place where possible to ensure continuity. 4.2	CCTV Projek	CCTV Project	
	<p>Met die begroting se goedkeuring by die pas afgelope AJV is die cctv projek ook goedgekeur. Die Trustees oorweeg die kwotasies wat vir die projek bekom is en die besluit om WiMation aan te stel word eenparig geneem. WiMation is die bestaande diensverskaffer en alhoewel hulle prys 'n klein bietjie duurder is, word besluit dat die voordeel van 'n enkele diensverskaffer die beste uitkoms sal bied. Verskillende diensverskaffers gebruik verskillende tegnologieë en is geneig om mekaar te blameer indien iets sou verkeerd gaan.</p> <p>AvH sal die instruksie aan SM gee om die deposito te betaal om die projek aan die gang te kry. Die toerusting behoort by die einde van Junie afgelever te wees en installasie sal dan begin.</p>	<p>With the budget's approval at the recent AGM, the cctv project was also approved. The Trustees considered the quotes obtained for the project and the decision to appoint WiMation is made unanimously. WiMation is the existing service provider and although their price is a little bit more expensive, it is decided that the benefit of a single service provider will provide the best outcome. Different service providers use different technologies and tend to blame each other if something goes wrong.</p> <p>AvH will give the instruction to SM to pay the deposit to get the project started. The equipment should be delivered by the end of June and installation will then begin.</p>	AvH

	'n Verskaffer is gevind vir die proppe wat nodig is om te keer dat water in die palissade hening se pale beland. Besluit word geneem om 45 proppe aan te koop sodat pale behoorlik in stand gehou kan word. EP sal propper aankoop.	A supplier was found for the caps needed to prevent water from getting into the palisade fence's posts. Decision is taken to purchase 45 caps so that poles can be properly maintained. EP will purchase the caps.	EP
4.5	BR052 versoek vir grensheining	BR052 request for boundary fence	
	'n Versoek is ontvang vanaf BR052 om 'n 600mm hoë grensheining van Clear-Vu rondom agterplaas te installeer. Versoek word goedgekeur met vereiste dat dit nie vanaf die pad sigbaar mag wees nie soos deur Argitektoniese reëls vereis word. AvH sal 'n antwoord aan BR052 voorberei vir SM om uit te stuur.	A request was received from BR052 to install a 600mm high Clear-Vu boundary fence around backyard. Request is approved with requirement that it must not be visible from the road as required by Architectural rules. AvH will prepare an answer for BR052 for SM to send out.	AvH
4.6	BR094 Blombedding	BR094 Flowerbed	
	'n Versoek vanaf BR094 vir Blue Ridge se HEV om verantwoordelikheid vir die instandhouding van die blombedding aan die westekant oor te neem. Die blombedding val hoofsaaklik in die algemene eiendom as deel van die groenstrook en die Trustees staan die versoek toe. Dit sal toelaat dat die keuse van plante en die instandhouding binne die beheer van die HEV sal val en tot voordeel van die algemene stand van die tuine wees. EP sal dit so implementeer en AvH sal inwoner inlig.	A request from BR094 for Blue Ridge's HOA to take over responsibility for the maintenance of the flower bed on the western side. The flower bed falls primarily into the common property as part of the green strip and the Trustees grant the request. This will allow the selection of plants and the maintenance to fall within the control of the HOA and benefit the general condition of the gardens. EP will implement it that way and AvH will inform resident.	EP AvH
4.7	Straatligte in Floraweg	Streetlights in Flora Road	
	Die ligte aan die Oostelike grensmuur van Floraweg word gereeld deur reënweer geaffekteer agt die oorspronklike swak installasie van die elektriese kabels. Dit veroorsaak ook dat die cctv kameras op die Noord-Oostelike hoek geaffekteer word. Die kabels is nou behoorlik in pype geïnstalleer en die ligte en cctv kameras is op aparte skakelaars gesit. Dieselfde probleem bestaan aan die Westekant van die pad en PB sal CBS vra om ook 'n kwotasie te gee om daardie kant ook reg te stel.	The lights on the Eastern boundary wall of Flora Road are regularly affected by rainy weather due to the original poor installation of the electrical cables. This also causes the cctv cameras on the North-Eastern corner to be affected. The cables are now properly installed in pipes and the lights and cctv cameras have been put on separate trip switches. The same problem exists on the Western side of the road and PB will ask CBS to provide a quote to fix that side as well.	

4.8	Frekwensie van Trustee vergaderings	Frequency of Trustee meetings	
	AvH maak 'n voorstel dat Trustee vergaderings slegs elke twee maande gehou word. Sodra die cctv projek voltooi is sal die landgoed grootliks in 'n instandhoudings modus ingaan en agt die effektiewe manier waarop die Trustees in die voorafgaande jaar besluite en kommunikasie via e-pos en WhatsApp hanteer het, is die gevoel dat maandelikse vergaderings nie meer nodig is nie. Die grondwet vereis slegs 'n minimum van kwartaallikse vergaderings. Die Trustees ondersteun die voorstel en vergaderings sal dus vanaf Julie slegs elke twee maande op die tweede Woensdag van die maand plaasvind.	AvH makes a proposal that Trustee meetings be held only every two months. Once the cctv project is completed, the estate will largely go into maintenance mode and due to the effective way in which the Trustees handled decisions and communication via email and WhatsApp in the previous year, the feeling is that monthly meetings are no longer necessary. The constitution requires only a minimum of quarterly meetings. The Trustees support the proposal, and meetings will therefore only take place every second month from July going forward on the second Wednesday of the month.	AvH
